Camp Minutes for October 2, 2016 Held at Memorial Hall Rockford, Ill.

The meeting was called to order by SVR Hoovler at 7:05 pm. There were 9 members present: Steve Aarli, Philip Brenning, Hugh DeGroff, Terry Dyer, Steve Haight, Richard Hoovler, Bill Johnson, Dave Johnson and John Wade.

SVC Richard Hoovler led the membership in opening prayer.

Acting Secretary Aarli called the roll of the membership.

The minutes of the October 2, 2016 Camp meeting were read. Bro. Steve Haight noted that his first name was misspelled should read Stephen not Steven. A motion was made, seconded and passed to accept as amended.

Encampment Bond redeemed \$200.00. Total balance: \$1128.75. Motion was made, seconded and passed to approve Treasurers report.

Communications: PCC Aarli highlighted recent Dept. Gen. Order #10 from DC Zeien. Bro. Aarli read an invitation letter via Dept. JVC Reineke IV that the 2 SCV Camps from Chicago and Sycamore will be having a joint Veterans Day lunch at the Elwood Steak and Fish House in Dekalb, Ill. on Nov. 12, 2016 starting at 1:00pm. A thank you letter from the American Legion was read for the recent donation to the Special Olympics.

Old Business: Byron monument rededication on Oct. 15, 2016 was discussed and was well attended. The Logan Camp was mentioned for their part in restoring the monument. The SUVCW was also mentioned for their work in preserving CW history.

PDC Dyer reported on the Nov. 11 Veterans Day activities at Memorial Hall. Start time for the dedication of the new soldier plaza on the east side of the Hall to start at 10:30 am and we should be there about 10:00 am. The evening concert with the Regimental Volunteer Band of Wisconsin will start at 6:00pm Bro's Hoovler, Thompson and Haight will assist in selling tickets at the door. New Section 7: The Camp Officer elections shall be held annually between the first meeting in October and the first meeting in December, inclusive. The Camp Commander, Secretary and Treasurer (or Secretary/Treasurer) shall not serve on the Camp Council.

New Section 8: The newly elected and appointed Camp Officers shall annually be installed at a regular Camp meeting to be held between the first meeting in November and the first meeting in January, inclusive. The Camp shall file a Form 22 Certificate of Election and Installation of Camp Officers (or its replacement) within thirty (30) days of the Camp Installation to the

Camp being suspended.

The proposed changes were received and ordered to lay over until our December meeting to be voted upon.

Installation will be held at the December meeting.
